Professional Development Services to increase the capacity of Cambridge educators to engage in and facilitate collaborative learning and collegial practice, focused on educational equity and adapting practice to meet the needs of all learners.

Specific responsibilities include periodic professional learning sessions with specific schools and departments, focused on increasing district-wide capacity for leading and facilitating collaborative learning and analysis of student work, determined in collaboration with Dr. Carolyn Turk, Maryann MacDonald and Chris Colbath-Hess. During FY 19-20, Gene Thompson-Grove and Associates provided professional development services to school leaders and staff through the following 5 projects:

Cambridgeport Community Conversations Sept-June

Year-long project supporting the Cambridgeport School in continuing dialogues about race and racism through collaborative planning and shared facilitation of community conversations with parents and school leadership. Planning and meeting attendance/facilitation support provided by two facilitators, Gene Thompson-Grove and Charline Alexandre-Joseph.

Rindge Avenue Upper School; Faculty Meetings, August-May

Focus on training in Equity and Culturally Responsive Practices. Co-planning and facilitation of 6 sessions led by 2 facilitators.
